New Business: Clerk Lueck requested that she attend year 3 of the Clerks Institute virtually for a cost of \$499. Moved by Mann, seconded by Beckstrand to have Kristin attend the Clerks Institute in July. Motion carried.

The ambulance building's garage door was hit by the ambulance on January 23rd, 2023. The ambulance was inside the building, the crew received a call and did not wait for the door to open fully before leaving. Aspirus called for a company that came out to fix the door temporarily. Trustee Buksa will be following up with Aspirus and the ambulance director and make sure that a new door has been ordered and will be getting put in.

Tom Olson, Director of Public Works, has requested the purchase of a new Skidsteer broom. The new broom will be smaller than the one we currently use to allow for better movement around the light poles on McComb Ave and to make it easier to not tear up the lawn along other Village cleared sidewalks. Moved by Bullis, seconded by Buksa to purchase the new broom at a cost of \$7,106.00 and to sell the old broom. Motion carried.

Streets – The Public Works department is busy trying to clean the ice off of the streets. The application has been submitted to the DOT for the replacement of the State Road bridge.

Park, Lake, & Rec – Trustee Buksa was asked if he was donating the pike pole to the Village or if he was loaning it to the Village. He will be donating the pike pole which will allow Bob Rusch to properly write the text for the Village Hall History display. The Park, Lake, & Rec committee will be going through the old Christmas decorations and hoping to order some new decorations by April 1st. President Schreiner set up an Inland Lake committee meeting which will be with the Rib Lake Fish & Game and the Public Works department for April 14th at 2 p.m. Dev., Bldgs., & Grounds – None
